AMEND JOSEPH LAWRENCE PARK PEDESTRIAN/BIKE PATH CONTRACT WITH  
PARAMOUNT ENTERPRISES, INC. AND APPROVE CHANGE ORDER NO. 1 FINAL

WHEREAS, the Township Committee, by Resolution #2011-143-14B, awarded a contract to Paramount Enterprises, Inc., for the purpose of performing certain work and services with respect to the Joseph Lawrence Park Pedestrian/Bike Path project in the Township of Bordentown; and

WHEREAS, Alaimo Group, the Township's agent responsible for supervising the project as aforesaid, for the Township of Bordentown, has advised the Township Committee, by way of December 19, 2011, correspondence and change order request and the submission of the appropriate certification that the existing contract amount should be increased to reflect an increase in material necessary to complete the project by Paramount Enterprises, Inc.; and

WHEREAS, N.J.A.C. 5:30-14.4 provides that the Governing Body may authorize change orders and amend contracts in accordance with the procedures set forth in said regulations; and

WHEREAS, the Township Committee has reviewed the aforementioned request and desires to act favorably with respect to same and to amend the contract accordingly and to approve the change order;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Bordentown, in the County of Burlington, State of New Jersey, as follows:

1. That the Township Committee, for the aforementioned reasons, hereby amends the aforementioned contract and increases the contract price by \$6,667.60 and the amended total \$292,317.60 in accordance with the terms and conditions of the aforementioned certification and December 19, 2011, correspondence and request being attached hereto as Exhibit A and made part hereof by reference hereto.
